THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 5205' (N 87 1/2° E) FROM Point 7437, (Shown on Roberts Mountains 15<sup>th</sup> Quad), NE 1/4 Sec 1, TOWNSHIP 23 1/2 RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SE 1/4 Sec 36 T24N R50E & NE 1/4 Sec 6 T23N R51E MDMB. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN S 2° 24' 30" E DIRECTION, AND 1450 FEET IN A/AN N 2° 24' 30" W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
