THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 4125' (N41°E) FROM Point 7437, (Shown on Roberts Mountains 15' Quad), NE 1/4 Sec 1, TOWNSHIP 23 1/2 RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NW 1/4 Sw 1/4's Sec 36 T24N R50E MDM #8 FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/N S2°24'30"E DIRECTION, AND 1450 FEET IN A/N N2°24'30"W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
