FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN S 2° 24' 30" E  
DIRECTION, AND 1450 FEET IN A/AN N 2° 24' 30" W DIRECTION,
