RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE  
SW 1/4 & SE 1/4 S. Sec 36 T24N R50E MDM 1B.  
FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN N2°24'30"W  
DIRECTION, AND 1450 FEET IN A/AN S2°24'30"E DIRECTION,  
AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600  
FEET WIDE AND 1500 FEET LONG.
