SE 1/4 Sec 36 T24N R50E MDM 1 B  
FROM THIS DISCOVERY MONUMENT THE UNDERSTIGNED CLAIMS 50 FEET IN A/WAN N2°24'30"W  
DIRECTION, AND 1450 FEET IN A/WAN S2°24'30"E DIRECTION,  
AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600  
FEET WIDE AND 1500 FEET LONG.
