

101155 CERTIFICATE OF LOCATION

THE UNDERSIGNED hereby certifies that ATLAS PRECIOUS METALS INC., by its agent, the undersigned, has located a mining claim in the Unknown Mining District, County of Eureka, State of Nevada, on a vein known as the N 5 11.
