North 750' to the West side center, a 4" x 4" x 4 1/2' wood post ; thence,

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1490 feet from the location monument in a Norther'y direction, and 10 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.
