Beginning at Corner No. 1, the Northeast corner, which is located 4500 feet South and 2700 feet East from the NE corner of Section 4, Township 25 North, Range 48 East, Mount Diablo Meridian; thence,

South 600' to the SE corner, a 4" x 4" x 4 1/2' wood post; thence,  
West 750' to the South side center, a 4" x 4" x 4 1/2' wood post; thence,  
West 750' to the SW corner, a 4" x 4" x 4 1/2' wood post; thence,  
North 600' to the NW corner, a 4" x 4" x 4 1/2' wood post; thence,  
East 750' to the North side center, a 4" x 4" x 4 1/2' wood post; thence,  
East 750' to the NE corner, a 4" x 4" x 4 1/2' wood post; the point and place of beginning.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1490 feet from the location monument in a Easterly direction, and 10 feet in a Westerly direction, together with 30' feet on each side of the center of the ledge for the entire length of the claim.

The monumentation and marking of the corners was completed by the 29th day of September, 1985.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$20.75 lode claim filing fee has been paid to the County Recorder.
