We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 10 feet from the location monument in a Northerly direction, and 1490 feet in a Southerly direction, together with 100 feet on each side of the center of the ledge for the entire length of the claim.
