South 750' to the SE corner, a 4" x 4" x 4 1/2' wood post ; thence,
West 600' to the SW corner, a 4" x 4" x 4 1/2' wood post ; thence,
North 750' to the West side center, a 4" x 4" x 4 1/2' wood post ; thence,
North 750' to the NW corner, a 4" x 4" x 4 1/2' wood post ; thence,
East 600' to the NE corner, a 4" x 4" x 4 1/2' wood post ; the
point and place of beginning.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 10 feet from the location monument in a Northerly direction, and 1490 feet in a Southerly direction, together with 200 feet on each side of the center of the ledge for the entire length of the claim.

The monumentation and marking of the corners was completed by the 29th day of September, 1985.
