- South 750' to the SE corner, a 4" x 4" x 4 1/2' wood post; thence,
- West 600' to the SW corner, a 4" x 4" x 4 1/2' wood post; thence,
- North 750' to the West side center, a 4" x 4" x 4 1/2' wood post; thence,
- North 750' to the NW corner, a 4" x 4" x 4 1/2' wood post; thence,
- East 600' to the NE corner, a 4" x 4" x 4 1/2' wood post; the

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1490 feet from the location monument in a Northerly direction, and 10 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.
