- North 750' to the West side center, a 4" x 4" x 4 1/2' wood post ; thence,
- North 750' to the NW corner, a 4" x 4" x 4 1/2' wood post ; thence,
- East 600' to the NE corner, a 4" x 4" x 4 1/2' wood post ; the
