Said work was performed on the Elements No. 47 and No. 52 claims.

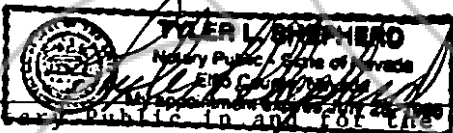
