# Certificate of Location of Lode Mining Claim

The undersigned hereby certifies that he has located the EM No. 7  
 Lode Mining Claim in the  
NW Quarter, Section 16, Township 34N, Range 51E, M.D.B. & M.,  
 in the Carlin Mining District, in Eureka County, in  
 the State of Nevada, on the 4th day of December, 1985.

The claim is 1500 feet long and 600 feet wide, and 1490 feet is  
 claimed in a East direction and 10 feet in a West direction from  
 the location monument, at which the Notice of Location is posted, lengthwise of  
 the claim, together with 300 feet in width on each side of the center of the  
 claim. The general course of the claim is from the East to the West.

The location and number of each corner of this claim is shown on the  
 claim map that is filed herewith. On the ground, each corner of the claim is  
 marked with its appropriate number by marking the claim name and number on an  
 aluminum tag.

The description of each corner is as follows:

- Northwest Corner No. 1 is a 4" x 5 ft. PVC pipe.
- North Side Center No. 2 is a 4" x 5 ft. PVC pipe.
- Northeast Corner No. 3 is a 4" x 5 ft. PVC pipe.
- Southeast Corner No. 4 is a 4" x 5 ft. PVC pipe.
- South Side Center No. 5 is a 4" x 5 ft. PVC pipe.
- Southwest Corner No. 6 is a 4" x 5 ft. PVC pipe.

The monumentation and marking of the corners was completed by the  
5th day of December, 1985. This claim is intended to cover all land  
 open to location existing within its boundaries as of this date of posting.

The location work consisted of making a claim map as provided in NRS  
 517.040. Two copies of this claim map have been filed with the Eureka  
 County Recorder, and the \$20.75 lode claim filing fee has been paid to the  
 County Recorder.
