CERTIFICATE OF LOCATION
LODE MINING CLAIM

Orion # 126 Lode Mining Claim

This is to certify that Orion Ltd. did on the 24th day of October, 1985 locate and claim, and does hereby locate and claim by right of discovery and location, and in compliance with the Mining Laws of the United States and the State of Nevada, and the local customs and rules of the district in which the claim is located, the lode mining claim called the Orion #126 mining claim in the:

SW 1/4 of Section 3, T.32N., R.49E., M.D.B. & M.
SE 1/4 of Section 4, T.32N., R.49E., M.D.B. & M.
NW 1/4 of Section 10, T.32N., R.49E., M.D.B. & M.
NE 1/4 of Section 9, T.32N., R.49E., M.D.B. & M.

in the unknown Mining District, Eureka County, State of Nevada.

The general course of the lode or vein as near as can be determined is in an Easterly direction from the location monument upon which the Notice of Location is posted. The undersigned claims 1495 feet in an Easterly direction and 5 feet in a Westerly direction from the location monument together with 300 feet on each side of the center of the vein or lode.

The position of each corner of this claim is shown on the mining claim map recorded herewith. The number, position and markings on each corner or side center monument is as follows:

As erected on the ground, each corner and sideline center monument consists of a 4" x 4" x 4 1/2' wood post set one foot in the ground and is marked as described above by an aluminum tag attached to the monument. The monumentation and marking of the above-described corners and sideline centers on the ground was completed within 20 days from the date of posting the Notice of Location; and the location work consisted of making and recording of duplicate claim maps and payment of the fees prescribed by NRS 517.040. Said claim map and description has been simultaneously filed herewith, in the County Recorder's office and the Nevada State BLM office and is by reference incorporated herein.
