Plaintiff, CEDAR RIDGE OIL AND GAS, INC., by and through
its attorney, RICHARD J. MATTHEWS, ESQ., filed an Application
for Default Judgment on the 28th day of August, 1985, together

2 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that judgment
3 be granted, and the same is hereby granted, to Plaintiff, CEDAR
4 RIDGE OIL AND GAS, INC. and against Defendant JAMES C. MORRIS,
5 ESQ., Personal Representative of the Estate of ROBERT D. MORRIS,
6 SR., Deceased, in accordance with the relief prayed for in Plaintiff's
7 Complaint as follows:

8 1. For damages in the principal amount of FIFTY-FIVE THOUSAND
9 DOLLARS (\$55,000.00), together with interest thereon at the rate
10 of eighteen (18%) percent per annum, commencing February 22,
11 1984, until said principal amount is paid in full; and,

12 2. For Plaintiff's costs of suit in the total amount of
13 TWO HUNDRED FIFTY-EIGHT DOLLARS (\$258.00) as shown on Plaintiff's
14 Memorandum of Costs filed herein; and,

15 3. For a reasonable attorney's fee incurred by Plaintiff
16 in the amount of \$1,250.00.
