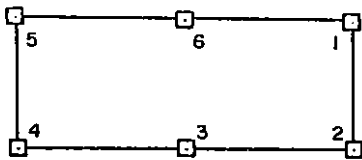


Diagram showing method of describing Mill Sites

NOTICE AND CERTIFICATE OF LOCATION - MILL SITE - NEVADA

NOTICE IS HEREBY GIVEN AND CERTIFIED that EXXON CORPORATION, by its under-
signed Agent, hereby locates the MT 834 Mill Site on this 6th day
of January, 1986, in accordance with the mining laws of the United States
of America and of the State of Nevada.

The name of the vein or lode claim or mine of which Exxon Corporation is
the proprietor is the following: LODE MINING claim LORRAINE No. 2 located
mostly in the NE $\frac{1}{4}$ Section 12, T. 22 N., R. 51 E., Eureka County, Nevada.

The number of feet or acres claimed in this Mill Site is 4.54 acres.

This Mill Site is located in the SE (Quarter) of Section(s) 16,
Township 22 N., Range 52 E., Mt. Diablo P.M., in the Mt. Hope Mining District,
Eureka County, Nevada, and is described as follows:

With reference to the diagram(s) shown above, beginning at the northeast
corner post No. 1,

- thence approximately 300 feet in a Southerly direction to Post No. 2,
- thence approximately 330 feet in a Westerly direction to Post No. 3,
- thence approximately 330 feet in a Westerly direction to Post No. 4,
- thence approximately 300 feet in a Northerly direction to Post No. 5,
- thence approximately 330 feet in a Easterly direction to Post No. 6,
- thence approximately 330 feet in a Easterly direction to Post No. 1,

The point of beginning and all posts referred to above measure 4 inches by
4 inches by $4\frac{1}{2}$ feet.

The monument on which this notice of location is posted is at a point
along the north boundary of the Mill Site approximately 0 feet from the
East side and 660 feet from the West side of the Mill Site.

To tie this Mill Site to an official corner of the United States public
land survey, begin at the SW corner of Section 30, Township 23 N., Range
52 E., Mt. Diablo P.M., bear South 19,500 feet, and East 17,000
feet, to the northeast corner of this Mill Site.
