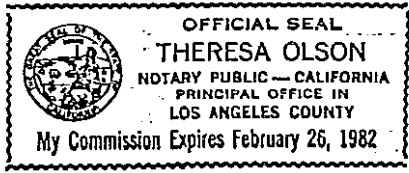

the sum of Ten Thousand Five Hundred and No/100 DOLLARS, with interest from May 1, 1982 Only on unpaid principal at the rate of Eight (8) per cent per annum; principal and interest payable in installments of One-Hundred (\$100.00) Dollars or more on the 1st day of each calendar month, beginning on the 1st day of December, 1980 and continuing until and including April 1st, 1982; Then Principal and Interest payable in installments of One-Hundred and No/100 Dollars (\$100.00) or more on the 1st day of each calendar month, beginning on the 1st day of May, 1982 and continuing until said principal and interest have been paid.
