

# Certificate of Location of Lode Mining Claim

The undersigned hereby certifies that he has located the EM No. 29  
 Lode Mining Claim in the  
NE Quarter, Section 10, Township 34N, Range 51E, M.D.B. & M.,  
 in the Carlin Mining District, in Eureka County, in  
 the State of Nevada, on the 11th day of January, 1986.

The claim is 1500 feet long and 600 feet wide, and 1490 feet is  
 claimed in a South direction and 10 feet in a North direction from  
 the location monument, at which the Notice of Location is posted, lengthwise of  
 the claim, together with 300 feet in width on each side of the center of the  
 claim. The general course of the claim is from the North to the South.

The location and number of each corner of this claim is shown on the  
 claim map that is filed herewith. On the ground, each corner of the claim is  
 marked with its appropriate number by marking the claim name and number on an  
 aluminum tag.

The description of each corner is as follows:

- Northwest Corner No. 1 is a 4" x 5 ft. PVC pipe.
- Northeast Corner No. 2 is a 4" x 5 ft. PVC pipe.
- East side Center No. 3 is a 4" x 5 ft. PVC pipe.
- Southeast Corner No. 4 is a 4" x 5 ft. PVC pipe.
- Southwest Corner No. 5 is a 4" x 5 ft. PVC pipe.
- West side Center No. 6 is a 4" x 5 ft. PVC pipe.

The monumentation and marking of the corners was completed by the  
11th day of January, 1986. This claim is intended to cover all land  
 open to location existing within its boundaries as of this date of posting.

The location work consisted of making a claim map as provided in NRS  
 517.040. Two copies of this claim map have been filed with the Eureka  
 County Recorder, and the \$20.75 lode claim filing fee has been paid to the  
 County Recorder.
