

CERTIFICATE OF LOCATION

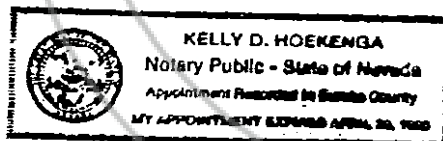
