CERTIFICATE OF LOCATION

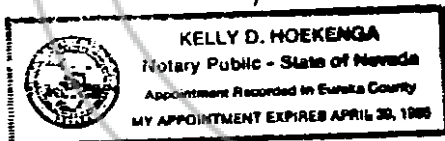
