

CERTIFICATE OF LOCATION

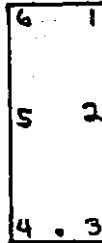
The UNDERSIGNED hereby certifies that ATLAS PRECIOUS METALS INC., by its agent, the undersigned, has located a mining claim in the UNKNOWN Mining District, County of EUREKA, State of Nevada, on a vein known as the NS130.

Said claim was located on the 14 day of November, 1985.

The locator claims 1500 linear feet in length in a NORTH/SOUTH direction along the course of said vein or lode running 1490 feet NORTH and 10 feet SOUTH, from the point of location at which this location certificate is posted, with a width of 300 linear feet on each side of the center of the vein or lode along the entire length of said claim.

the point of beginning, and all posts being 4" x 5" PVC.

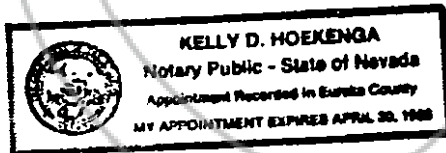
