CERTIFICATE OF LOCATION

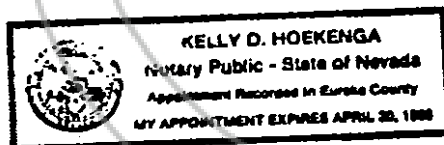
