CERTIFICATE OF LOCATION

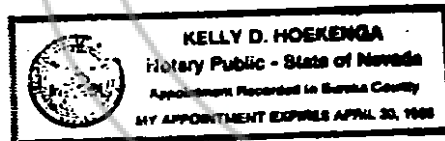
