CERTIFICATE OF LOCATION

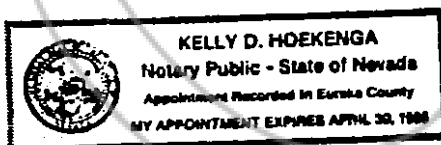
