CERTIFICATE OF LOCATION

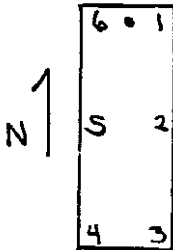

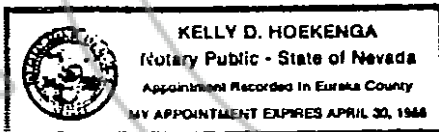
