CERTIFICATE OF LOCATION

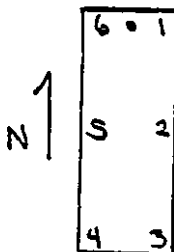
The UNDERSIGNED hereby certifies that ATLAS PRECIOUS METALS INC., by its agent, the undersigned, has located a mining claim in the UNKNOWN Mining District, County of EUREKA, State of Nevada, on a vein known as the NJ 211.

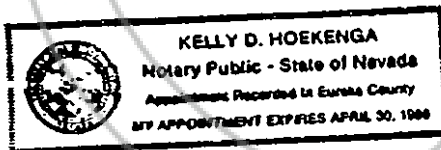
