The date of location is March 23, 1986. The number of linear feet claimed in the length along the course of the vein each way from the point of discovery, at which a discovery monument was erected and on which a notice of location was posted in accordance with applicable laws, is 950 feet North erly and 550 feet South erly, which is the general course of the lode or vein as near may be, and on the East erly side of the center of the vein 300 feet is claimed and on the West erly side of the center of the vein 300 feet is claimed.
