TSG No. 30. The name of the owner and locator is Tonkin Springs Gold Mining Company whose current mailing and post office address is 1600 Stout St. - Ste. 1600, Denver, CO 80202-3133. The date of location is February 25, 1986. The number of linear feet claimed in the length along the course of the vein each way from the point of discovery, at which a discovery monument was erected and on which a notice of location was posted in accordance with applicable laws, is 1420 feet West erly and 10 feet East erly, which is the general course of the lode or vein as near may be, and on the North erly side of the center of the vein 300 feet is claimed and on the South erly side the center of the vein 300 feet is claimed. Location work consisted of making the maps as provided by N.R.S. 517.040. At each corner of the claim and at the center of each side line there is a monument in compliance with N.R.S. 517.030, so marked as to designate the claim name and corner number.
