NOTICE IS HEREBY GIVEN that Tonkin Springs Gold Mining Company, a Nevada corporation, hereby claims by right of discovery and location under and pursuant to the laws of the United States of America and of the State of Nevada the following described lode mining claim, and in making this claim and for the purposes of establishing its right thereto, hereby certifies and states as follows: The name and/or number of the claim and lode or vein is TSG No. 54.

The name of the owner and locator is Tonkin Springs Gold Mining Company whose current mailing and post office address is 1600 Stout St.- Ste.1600, Denver, CO 80202-3133. The date of location is March 9, 1986.
