NOTICE IS HEREBY GIVEN that Tonkin Springs Gold Mining Company, a Nevada corporation, hereby claims by right of discovery and location under and pursuant to the laws of the United States of America and of the State of Nevada the following described lode mining claim, and in making this claim and for the purposes of establishing its right thereto, hereby certifies and states as follows: The name and/or number of the claim and lode or vein is

TSG No. 137. The name of the owner and locator is Tonkin Springs Gold Mining Company whose current mailing and post office address is 1600 Stout St.- Ste.1600, Denver, CO 80202-3133. The date of location is March 16, 1986. The number of linear feet claimed in the length along the course of the vein each way from the point of discovery, at which a discovery monument was erected and on which a notice of location was posted in accordance with applicable laws, is 750 feet North erly and 750 feet South erly, which is the general course of the lode or vein as near may be, and on the East erly side of the center of the vein 300 feet is claimed and on the West erly side of the center of the vein 300 feet is claimed. Location work consisted of making the maps as provided by N.R.S. 517.040. At each corner of the claim and at the center of each side line there is a monument in compliance with N.R.S. 517.030, so marked as to designate the claim name and corner number. The claim and its corners are more particularly described as follows: From Corner No. 1, the W 1/4 corner of Section 31, T. 24 N, Range 49 East of the Mt. Diablo P.M., if such corner exists, or a claim location marker constructed as specified in N.R.S. 517.040 if such corner does not exist, bears South a distance of 1,093 feet, thence East a distance of 400 feet, thence a distance of 600 feet. Beginning at Corner No. 1, thence East erly a distance of 600 feet to Corner No. 2; thence South erly a distance of 1500 feet to Corner No. 3; thence West erly a distance of 600 feet to Corner No. 4; thence North erly a distance of 1500 feet to Corner No. 1, the place of beginning. The East erly side center monument lies midway between corners 2 and 3 and the West erly side center monument lies midway between corners 4 and 1. The claim includes land within the following quarter section(s): NE 1/4 Section 24, Township 24 N, Range 48 1/2 E., SE 1/4 Section 24, Township 24 N, Range 48 1/2 E., NW 1/4 Section 19, Township 24 N, Range 49 E., SW 1/4 Section 19, Township 24 N, Range 49 E., of the Mt. Diablo P.M.
