

## NOTICE OF CORRECTION TO ASSIGNMENT

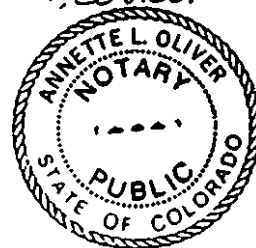
