CERTIFICATE OF RELOCATION OF LODE MINING CLAIM

The undersigned hereby certifies that he has relocated the Rat No. 18 Lode Mining Claim in the NW Quarter, Section 22, Township 18 N, Range S3E, M.D.B. & M., in the Eureka Mining District, in Eureka County, in the State of Nevada, on the 10th day of March, 1986.

The claim is a relocation of the Rat No. 18 Lode Mining Claim which is of record in the office of the Recorder of Eureka County, Nevada in Book 50, Page 226, in accordance with N.R.S. 517.080.

Southeast Corner is a 4"x5' PVC pipe or blazed tree inscribed	SE Corner Rat #	<u>18</u>
Southwest Corner is a 4"x5' PVC pipe or blazed tree inscribed	SW Corner Rat #	<u>18</u>
West Side Center is a 4"x5' PVC pipe or blazed tree inscribed	WS Center Rat #	<u>18</u>
