CERTIFICATE OF RELOCATION OF LODE MINING CLAIM

The undersigned hereby certifies that he has relocated the Rat No. 32 Lode Mining Claim in the S6 Quarter, Section 21, Township 18 N., Range 63, M.D.B. & M., in the Eureka Mining District, in Eureka County, in the State of Nevada, on the 10th day of March, 1986.

The claim is a relocation of the Rat No. 32 Lode Mining Claim which is of record in the office of the Recorder of Eureka County, Nevada in Book 65, Page 191, in accordance with N.R.S. 517.080.

The claim is 1500 feet long and 600 feet wide, and 1295 feet is claimed in a southerly direction and 205 feet in a northerly direction from the location monument, at which the Notice of Location is posted, length of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the south to the north.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by marking the claim name and number on an aluminum tag.

The description of each corner is as follows:

- Northwest Corner is a 4"x5' PVC pipe or blazed tree inscribed NW Corner Rat # 32
- Northeast Corner is a 4"x5' PVC pipe or blazed tree inscribed NE Corner Rat # 32
- East Side Center is a 4"x5' PVC pipe or blazed tree inscribed ES Center Rat # 32
- Southeast Corner is a 4"x5' PVC pipe or blazed tree inscribed SE Corner Rat # 32
- Southwest Corner is a 4"x5' PVC pipe or blazed tree inscribed SW Corner Rat # 32
- West Side Center is a 4"x5' PVC pipe or blazed tree inscribed WS Center Rat # 32

The work of location consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder.
