WHEREAS, the parties hereto desire to correct certain typographical errors contained in the Short Form and agree to restate the corrected terms contained therein.

"... this lease shall remain in force and effect for a period of fifteen (15) years from the date hereof, called the 'primary term', ..."

2. The second line of the second paragraph is hereby deleted in its entirety and is restated, as corrected, as follows:

". . . those certain lands included in said lease, situated in the County of Eureka, . . ."

3. Except as specifically corrected hereby the Short Form shall remain in full force and effect and the parties hereto reaffirm each and all terms and provisions of the Short Form as so corrected. The parties affirm that the lease remains in full force and effect and hereby reaffirm each and all terms of and provisions of the lease.
