13 the 21st day of May, 1986, at 1:00 p.m.; the Petitioner, as the
14 proposed Guardian, appeared in person and by and through his
15 Attorney, STEWART R. WILSON, ESQ., of the law firm of WILSON and
16 BARROWS, LTD.; attendance of the proposed Ward was excused; no
17 person appeared in opposition to said Petition; the Court heard
18 Petitioner's evidence and arguments; the matter was submitted,
19 AND GOOD CAUSE APPEARING THEREFOR,

20 THE COURT HEREBY FINDS AND CONCLUDES:

- 21 1. That all notices of the hearing of said Petition
22 have been given as required by law;
23 2. That the Court has jurisdiction and proper venue of
24 the matter herein;
25 3. The Ward, DAN FILIPPINI, is a resident of Elko,

27 4. That the facts alleged in the Petition are true in

3 6. A Guardian of the Estate of DAN FILIPPINI
4 should be appointed;

5 7. That HENRY A. FILIPPINI is qualified in all respects
6 to act as Guardian of the Estate of DAN FILIPPINI, ACCORDINGLY,
7 IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

8 1. HENRY A. FILIPPINI is hereby appointed as the Guardian
9 of the Estate of DAN FILIPPINI, an Adult Ward;

10 2. The names and addresses of the heirs at law and
11 next of kin of the Ward upon whom notice of proceedings herein
12 must be served are as follows:

16 3. The Guardian shall have all of the general powers
17 of a Guardian as provided by law, including, without limitation,
18 the power to cash social security and pension checks, pay Ruby
19 Mountains Manor, renew and cash Certificates of Deposit, and
20 generally pay bills from Ward's savings and checking accounts and
21 other funds;

22 4. A certified copy of this Order shall be recorded in
23 the County of Elko, State of Nevada, and any other county in which
24 the Guardian determines that the Ward has an interest in real
25 property therein.

26 5. Letters of Guardianship shall issue to HENRY A.
27 FILIPPINI upon his taking the oath of office as provided by law and
28 filing a bond or other undertaking in the sum of \$25,000.01 in a
