R50E. MDM EB FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/AN N 2° 24' 30" W DIRECTION, AND 1490 FEET IN A/AN S 2° 24' 30" E DIRECTION, AND 150 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 300 FEET WIDE AND 1,500 FEET LONG.
