THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY FROM THE SOUTHEAST CORNER OF SECTION 24, TOWNSHIP 24 NORTH, RANGE 50 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SE 1/4 Sec. 24 and NE 1/4 Sec. 25 T24N, R50E MDM 18 FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/H N 2° 24' 30" W DIRECTION, AND 1490 FEET IN A/H S 2° 24' 30" E DIRECTION, AND 150 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 300 FEET WIDE AND 1,500 FEET LONG.
