R 50 E. NDM & B. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 200 FEET IN A/AN S 2° 24' 30" E DIRECTION, AND 1300 FEET IN A/AN N 2° 24' 35" W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
