THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 6880' N47°W FROM THE SOUTHEAST CORNER OF SECTION 36, TOWNSHIP 24 NORTH, RANGE 50 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SW 1/4 Sec 25 and NW 1/4 Sec 36 T24N R50E MDM&B. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 200 FEET IN A/AN S 2°24'30" E DIRECTION, AND 1300 FEET IN A/AN N 2°24'30" W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.

THERE ARE 7 POSTS AT LEAST 4 INCHES IN DIAMETER BY 4-1/2 FEET LONG SET 1 FOOT IN THE GROUND, ONE FOR THE DISCOVERY MONUMENT, ONE FOR EACH OF THE FOUR CORNERS AND ONE AT THE CENTER OF EACH SIDE LINE AS PRESCRIBED BY N.S.R. SECTION 517.030.
