THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 6290' N14°E FROM THE SOUTHEAST CORNER OF SECTION 36, TOWNSHIP 24 NORTH, RANGE 50 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SW 1/4 Sec 30 T24N R51E MDM 1 B. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/AN S2°24'30"E DIRECTION, AND 1490 FEET IN A/AN N2°24'30"W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
