FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/N S 2°24'30" E DIRECTION, AND 1490 FEET IN A/N N 2°24'30" W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN.
