THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 2560' S 52°30' W FROM THE SOUTHEAST CORNER OF SECTION 24, TOWNSHIP 24 NORTH, RANGE 50 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NE 1/4 SEC 25 T 24 N R 50 E MDM JB FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/AN S 2°24'30" E DIRECTION, AND 1490 FEET IN A/AN N 2°24'30" W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
