THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1530' S 87°W FROM THE SOUTHEAST CORNER OF SECTION 36, TOWNSHIP 24 NORTH, RANGE 50 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NE 1/4 Sec. 25 T24N R50E MDM#8. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/AN N 2°24'30" W DIRECTION, AND 1490 FEET IN A/AN S 2°24'30" E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
