THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 3090' N63°W FROM THE SOUTHEAST CORNER OF SECTION 24, TOWNSHIP 24 NORTH, RANGE 50 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SW 1/4 Sec 24 T24N R50E AND NE 1/4 Sec 25 T24N R50E MDM 1 B FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/AN N2°24'30"W DIRECTION, AND 1490 FEET IN A/AN S2°24'30'E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
