MEMORANDUM OF MINERAL LEASE

THIS MEMORANDUM, dated as of the 8 day of May, 1986, discloses of record that for the term and on the terms and conditions of that certain Mineral Lease of even date herewith whereby LYLE F. CAMPBELL, an individual, of P.O. Box 7377, Reno, Nevada 89510, (hereinafter referred to as "LESSOR"), leased and does hereby lease, for good and valuable consideration to RAYROCK MINES, INC., dba CORDEX EXPLORATION COMPANY, (hereinafter referred to as "LESSEE") those certain unpatented mining claims generally located in Eureka County, Nevada, more particularly described in Exhibit A attached hereto and incorporated herein by reference.

The term of the Mineral Lease is for a TWENTY (20)-year period, commencing on the date hereof, with the option, at the LESSEE'S discretion, to renew for up to FOUR (4) successive TWENTY (20)-year periods, unless sooner terminated, forfeited or surrendered.

The LESSEE, under the terms of the Mineral Lease, shall have the exclusive right to enter upon the property for mining, milling and related purposes and may erect and maintain buildings thereof, and such use is to continue through the term of the Mineral Lease without further consideration, except as set forth in said Mineral Lease. All of the terms and conditions of the Mineral Lease are incorporated herein and made a part hereof as if set forth in full, and the consideration for such is recited therein.

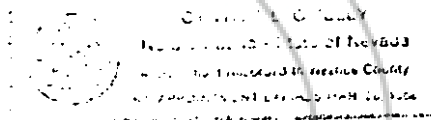

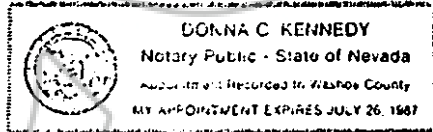

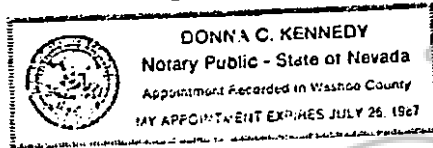
