The Claim is approximately 1500 feet long and 600 feet wide, such that 100 feet is claimed in a Northerly direction and 1400 feet in a Southerly direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the North to the South direction.

This amended location is made in conformity with the original location made by Carlin Gold Mining Company, Recorded in Eureka County, Nevada, in Book 54, Page 532 in the office of the Recorder of said County, and it is made for the purpose of appropriating all ground within the boundaries herein before described and of more definitely describing the situation and boundaries of said lode, correcting any irregularities, informalities or errors, supplying omissions and correcting any defects which may have existed in the original location.
