THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 6090' S 66°00'W FROM THE SOUTHWEST CORNER OF SECTION 30, TOWNSHIP 23NORTH, RANGE 51 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NE 1/4 & SE 1/4 SEC. 35, NW 1/4 & SW 1/4 SEC. 36, T. 23N. R. 50E. MDMB. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN SOUTH DIRECTION, AND 1450 FEET IN A/AN NORTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
