THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 3780' 548°30'E FROM THE SOUTHWEST CORNER OF SECTION 30, TOWNSHIP 23 NORTH, RANGE 51 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NW 1/4 NE 1/4 SEC 31 T 23 N R 51 E MDM & B FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN SOUTH DIRECTION, AND 1450 FEET IN A/AN NORTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.

THERE ARE 7 POSTS AT LEAST 4 INCHES IN DIAMETER BY 4-1/2 FEET LONG SET 1 FOOT IN THE GROUND, ONE FOR THE DISCOVERY MONUMENT, ONE FOR EACH OF THE FOUR CORNERS AND ONE AT THE CENTER OF EACH SIDE LINE AS PRESCRIBED BY N.S.R. SECTION 517.030.
