THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 5220' N 52°00' W FROM THE SOUTH WEST CORNER OF SECTION 30, TOWNSHIP 23 NORTH, RANGE 51 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NW 1/4 & SW 1/4 Sec. 25 T.23N. R.50E. MDMER. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN NORTH DIRECTION, AND 1450 FEET IN A/AN SOUTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
